Submission Guidelines

We welcome high-quality, unpublished research in all areas of finance, including but not limited to:

Both completed papers and well-developed proposals will be considered. Submissions will undergo a double-blind peer review process. At least one author of each accepted paper must register and present at the conference. Presenters who have not signed up to discuss by February 1, 2026 may have their papers removed from the program. Presenters must register by February 9, 2026 to be included in the program.
